The National Safety Council's **Million Work Hours Award** recognizes companies, locations or divisions that have completed a period of at least one million work hours without incurring an occupational injury or illness that resulted in days away from work or death.

| <ul style="list-style-type: none"> In accordance with the OSHA record keeping requirements, a company, location or division must have continued without the occurrence of an occupational injury or illness involving days away from work or death. Applicant must have accomplished 1, 2, 3, etc. million consecutive work hours over this period. Eligibility is determined based on self-reported data submitted by the participant, which must be submitted within 60 days from the date the total hours were reached. Any organization recording a fatality will be disqualified. | <ul style="list-style-type: none"> Qualified companies, locations or divisions can purchase a Million Work Hours Award to display their achievement at their organization.
