



## MILESTONE AWARD

The National Safety Council's **Milestone Award** recognizes companies, locations and divisions that have completed a period of at least 30 consecutive days without incurring an occupational injury or illness that resulted in days away from work or death.

CRITERIA:	RECOGNITION:
<ul style="list-style-type: none"> <li>In accordance with the OSHA record keeping requirements, a company, location or division must have continued without the occurrence of an occupational injury or illness involving days away from work or death for a period of at least 30 consecutive days.</li> <li>Milestone recognition can be recorded by the number of days, weeks, months or years.</li> <li>Eligibility is determined based on self-reported data submitted by the participant. Any organization recording a fatality will be disqualified.</li> </ul>	<ul style="list-style-type: none"> <li>Qualified companies, locations or divisions can purchase a Milestone Award to display their achievement at their organization.</li> <li><b>Pricing:</b> Engraved Plaque \$89.95 Wood Frame Certificate \$89.95 (plus shipping, handling and applicable tax).</li> </ul>
