The National Safety Council's **Safety Leadership Award** recognizes companies, locations or divisions that have achieved a minimum of five consecutive "perfect record" years, operating without incurring an occupational injury or illness resulting in days away from work or death.

CRITERIA:	RECOGNITION:
<ul style="list-style-type: none"> <li>Participants must have zero fatalities, zero injuries, and zero illnesses that involved days away from work in their 6-digit NAICS Code during a consecutive five year period (extending at least 60 months in duration).</li> <li>Any organization recording a fatality or injury that involved days away from work will not be considered.</li> </ul>	<ul style="list-style-type: none"> <li>Qualified companies, locations or divisions can purchase a Safety Leadership Award to display their achievement at their organization.</li> <li><u>Pricing:</u> Etched Crystal \$169.95 (plus shipping, handling and applicable tax).</li> </ul>
